Purpose and aim of the competition on the merits

The purpose of the International Competition on the merits of shoemaker trade is to demonstrate the technical performance level of **young professionals**.

Group of participants

Eligible to participate in this competition on the merits are all trainees from Europe **in the year before graduation**. Training may be in factories, but also in technical colleges / educational institutions.

Competition items

2 competition items must be submitted (1 pair of worn men's shoes and 1 pair of worn women's shoes = **1 unit**).

Following repairs must be carried out thereon:

a) **Pair of worn men's shoes:**

Both shoes with new leather half soles glued, heel tips of choice.

b) **Pair of worn women's shoes:**

One shoe with a protection sole, both shoes with new heel tips.

The submitted competition / participation items must be processed by the participants themselves. This must be confirmed on the registration by the participant and the training company/ educational institute/ technical college.

Registrations

The registration of competition items for the Junior competition on the merits must be made in duplicate on application forms attached to these conditions of participation.

A copy of the report form (with **original** signed) must be received **latest by 10th December 2015** at the Zentralverband des Deutschen Schuhmacher-Handwerks (ZDS), Postfach 15 64, D – 53733 Sankt Augustin.

Contribution towards expenses

To cover the expenses (transportation, insurance, medals, certificates of participation) an amount of **Euro 47.00** (+ € 24.00 for return) must be paid **for the unit**.

Competition items, for which the costs have not been paid on time, will be **excluded** from participating to the competition.

Sending the competition items

The second, identical copy of the registration form (with the **1st duplicate** signed) must be enclosed when sending the competition items. The third, identical copy of the registration form (with the 2nd duplicate signed) remains with the contestants for their records.

IMPORTANT NOTE:

Competition items must be sent **post-paid** so that they reach the **latest until Friday, 15th January 2016** at the collecting point:

The address of the collecting point shall be notified upon confirmation of participation.

Competition items shall be returned to the participants **after** the end of "Inter-Schuh-Service ISS 2016" Shoemaker's trade exhibition.

Jury

The awarding of the submitted competition items and the selection of participation items shall be made by a jury of experts convened by the Central Association of the German Shoemakers' Trade (ZDS). The evaluation and selection of participation items by the jury is based on a point system. **The decision of the jury is final.**

Awarding

Competition items are awarded with medals accompanied by a certificate. For not awarded with medals but appreciable competition items the sender shall receive a participation certificate.

Display

All competition items shall be displayed at the "Inter-Schuh-Service ISS 2016" International Shoemaker trade exhibition on 12th and 13th March 2016 in Hofheim-Wallau.

Participants are required to keep the submitted competition/ participation items available to the show organizers until the official closing of the exhibition.
